

Pitcher Perfect Contest

Rules & Requirements

Who Can Participate

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a UHFCU member eighteen (18) years of age or older as of May 11, 2019 to enter. In addition, to qualify, <u>you must register for the contest</u> and be the primary member on a Savings account at UHFCU.

How to Participate
