

Rules & Requirements

## Who Can Participate

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a resident of the State of Hawai'i and eighteen (18) years of age or older with a valid Social Security Number as of May 26, 2019 to enter.
