

# e.Statements - iPad Contest

Rules & Requirements

The e.Statement iPad Contest ("Contest") begins 12:01 AM HST on June 1, 2019 and ends 11:59 PM HST on July 31, 2019 and is subject to all applicable federal, state, and local laws and regulations. All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant shall be governed by, and construed in accordance with the laws of the State of Hawai i.

### Who Can Participate

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a resident of the State of Hawai'i and eighteen (18) years of age or older with a valid Social Security Number as of July 31, 2019 to enter. In addition, to qualify for automatic entry, you must be the primary member on a Savings account at UHFCU, utilize our e.Statement service through the end of the Contest period, and all of your accounts must be in good standing. This promotion excludes UHFCU employees, Board of Directors, and Volunteers, as well as their spouses, dependent children or household members. Business accounts are ineligible.

## How to Participate

There are two options to participate in the Contest's prize drawing:

- 1. No purchase or credit union transaction necessary to enter. To enter the Contest without a purchase or credit union transaction, UHFCU members may enter by writing their full name, address, date of birth, daytime phone number, e-mail address, and writing "e.Statement iPad Contest" on a 3x5 postcard and hand delivering to a UHFCU branch office or mailing to: UHFCU, Attention: Marketing e.Statement iPad Contest, P.O. Box 22070, Honolulu, HI 96823. Limit one entry per member. Multiple entries by any one person, incomplete, or illegible entries will result in disqualification. Must be postmarked or hand-delivered by 5:00 p.m. (HST) on July 31, 2019.
- 2. <u>Members must register for the contest</u> in person, by phone, by mail, or through secure messaging within Online Banking. Qualifying members will be automatically entered into the random drawing to win the prize described below when enrolled (new <u>and</u> existing enrollees are eligible) in the e.Statement service through July 31, 2019. All entries will be deemed to have been made by the primary accountholder. Other transactions do not qualify.

#### Prize

One (1) winner will be awarded one (1) Apple iPad. The total approximate retail value of the prize is \$330.00. The winner may not choose cash or an alternative prize. Winner is responsible for any/all travel costs to redeem prize.

### **How Winners Will Be Determined**

One random entry will be drawn for the prize listed above. The member associated with the entry will be the potential winner. Odds of winning are dependent on the number of entries received. The winner's name can be provided upon request.

The potential winner will be selected by random drawing on or about August 7, 2019 and notified within 2 business days of the drawing by the phone number we have on file. All decisions will be final. No participant or winner shall have the right to challenge or contest any decision of UHFCU, e.Statement iPad Contest, its rules, interpretation, determination, eligibility, verification, timeliness, winner, prize, or any other matter. Winner will be notified by phone. The winner will need to respond within (24) twenty-four hours in order to claim prize. If the winner does not respond within the period, an alternate winner will be selected. Prize notifications returned as undeliverable or unclaimed will be forfeited and awarded to an alternate winner. Winner need not be present to win. No prize substitution will be permitted.

Winners will be required to present a photo I.D. and sign an affidavit of eligibility/liability/publicity release. In the event of non-compliance with this requirement, prize may be forfeited and awarded to an alternate winner. Acceptance of the prize shall constitute and signify the winner's agreement and consent to use the winner's name, and/or photograph for promotional purposes by UHFCU without further compensation, consideration or payment.
