

# Credit Card - Las Vegas Sweepstakes

Rules & Requirements

The Credit Card Las Vegas Sweepstakes ("Sweepstakes") begins 12:01 AM HST on November 1, 2021 and ends 11:59 PM HST on December 31, 2021 and is subject to all applicable federal, state, and local laws and regulations. All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant shall be governed by, and construed in accordance with the laws of the State of Hawai'i.

## Who Can Participate

Must be a resident of the State of Hawai'i and twenty-one (21) years of age or older with a valid Social Security Number as of December 31, 2021 to enter. In addition, to qualify, you must be the primary cardholder of a UHFCU Credit Card and all of your accounts must be in good standing. This promotion excludes UHFCU employees, Board of Directors, and Volunteers, as well as their spouses, dependent children or household members. Business accounts are ineligible.

#### How to Participate

There are two options to participate in the Sweepstake's prize drawing:

- 1. No purchase or credit union transaction necessary to enter. To enter the Sweepstakes without a purchase or credit union transaction, UHFCU members may enter by writing their full name, address, date of birth, daytime phone number, e-mail address, and writing "Credit Card Las Vegas Sweepstakes" on a 3x5 postcard and hand delivering to a UHFCU branch office or mailing to: UHFCU, Attention: Marketing Credit Card Sweepstakes, P.O. Box 22070, Honolulu, HI 96823. Limit one entry per member. Multiple entries by any one person, incomplete, or illegible entries will result in disqualification. Must be postmarked or hand-delivered by 5:00 p.m. (HST) on December 31, 2021.
- 2. Primary cardholders will receive one (I) entry when they make at least one thousand dollars (\$1,000) in purchases with their UHFCU credit card between 11/1/21 and 11/30/21. Primary cardholders will receive one (I) additional entry for making at least one thousand dollars (\$1,000) in purchases with their UHFCU credit card between 12/1/21 and 12/31/21. Up to two (2) entries per card. Balance transfers, cash advances, returns, and other transactions do not qualify.

#### **Prizes**

One (I) winner will each be awarded one (I) voucher from Vacations Hawaii. The voucher must be redeemed within 12 months of issuance and is good for a round-trip for two (2) to Las Vegas on allowable 4/5 night charter patterns, which includes air, hotel, meal package (for adults 21 years or older), and a 4-night stay at the Cal, Fremont, or Main Street Station. The total approximate retail value of the prize is \$1,800.00. The winner may not choose cash or an alternative prize. Winner is solely responsible for any federal, state, and local taxes in addition to any/all travel costs to redeem prize.

## **How Winners Will Be Determined**

One random entry will be drawn for the prize listed above. The member associated with the entry will be the potential winner. Odds of winning are dependent on the number of entries received. The winner's name can be provided upon request.

The potential winner will be selected by random drawing on or about January 15, 2022 and notified within 2 business days of the drawing by the phone number we have on file. All decisions will be final. No participant or winner shall have the right to challenge or contest any decision of UHFCU, Credit Card Las Vegas Sweepstakes, its rules, interpretation, determination, eligibility, verification, timeliness, winner, prize, or any other matter. Winner will be notified by phone and/or e-mail. The winners will need to respond within (24) twenty-four hours in order to claim prize. If a winner does not respond within the period, an alternate winner will be selected. Prize notifications returned as undeliverable or unclaimed will be forfeited and awarded to an alternate winner. Winner need not be present to win. No prize substitution will be permitted.

Winner will be required to present a photo I.D. and sign an affidavit of eligibility/liability/publicity release. In the event of non-compliance with this requirement, prize may be forfeited and awarded to an alternate winner. Acceptance of the prize shall constitute and signify the winner's agreement and consent to use the winner's name, and/or photograph for promotional purposes by UHFCU without further compensation, consideration or payment.
