International Credit Union Day Amazon Gift Card Sweepstakes

Rules & Requirements

The International Credit Union Day and Amazon Sweepstakes Enrollment Contest begins 12:01 AM HST on Thursday, October 20, 2022, and ends 11:59 PM HST on Saturday, October 22, 2022, and is subject to all applicable federal, state, and local laws and regulations. The contest is sponsored by the University of Hawai'i Federal Credit Union (UHFCU). Who Can Participate

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a resident of the State of Hawai'i and eighteen (18) years of age or older as of October 22, 2022, to enter. This promotion excludes UHFCU employees, Board of Directors, and Volunteers, as well as their spouses, dependent children, or household members.

How to Enter

There are 2 options to enter in the Contest's prize drawing:

I. No purchase or credit union transaction necessary to enter. Box 22070, Honolulu, HI 96823. Limit one entry per person. Multiple entries by any one person, incomplete, or illegible entries will result in disqualification. Must be postmarked or hand-delivered by October 22, 2022.

2. <u>Entrants must register for the contest</u>. Beginning October 20, 2022, register for the contest by doing at least one of the following:

- 1) Follow UHFCU on Facebook (<u>www.facebook.com/uhfcu</u>) or Instagram (<u>www.instagram.com/uhfcu</u>) & tag a friend on our Amazon Gift Card Sweepstakes post. Earn one entry per tagged friend, per social media channel.
- 2) Visit any UHFCU branch and enter in-person. One entry per completed form one maximum.

Entries must be received by 11:59 pm H.S.T., Saturday, October 22, 2022, to qualify. All entries become the property of Sponsors, and Sponsors reserve the right to use any information submitted by entrants.

Entries must be filled out completely and legibly to qualify, and will be void if they are, in whole or in part, incomplete, illegible, damaged, irregular, counterfeit, altered, or obtained through theft or fraud. One (1) winner will be randomly selected on Facebook or Instagram. One (1) winner will be randomly selected at each branch location (3 total).
