

The Hilton Hawaiian Village Sweepstakes begins 12:01 AM HST on June 21, 2023, and ends 11:59 PM HST on July 31, 2023, and is subject to all applicable federal, state, and local laws and regulations. The sweepstakes is sponsored by the University of Hawai'i Federal Credit Union (UHFCU). All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of any entrant shall be governed by, and construed in accordance with the laws of the State of Hawai'i.

**Who Can Participate**

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a resident of the State of Hawai'i and eighteen (18) years of age or older as of July 31, 2023, to enter. In addition, to qualify for entry, you must enter as detailed below. This promotion excludes UHFCU employees, Board of Directors, and Volunteers, as well as their spouses, dependent children or household members.

**How to Participate**

There are 2 options to participate in the Sweepstakes prize drawing:

1. No purchase or credit union transaction necessary to enter. ### **Prize**
