

The Credit Card Holiday Shopping Sweepstakes (sweepstakes) begins 12:01 AM HST on November 1, 2024, and ends 11:59 PM HST on December 31, 2024 and is subject to all applicable federal, state, and local laws and regulations. ### **Who Can Participate**

NO PURCHASE OR CREDIT UNION TRANSACTION NECESSARY TO ENTER OR TO WIN. Must be a resident of the State of Hawai'i and eighteen (18) years of age or older with a valid Social Security Number as of December 31, 2024, to enter. Must be the primary member on a Savings account at UHFCU and in good standing. In addition, to qualify for entry, member must be Platinum Plus & Cash Wave Credit Cardholders. Maximum two (2) entries per member. This promotion excludes UHFCU employees, the Board of Directors, and Volunteers, as well as their spouses, dependent children, or household members.

### **How to Participate**

There are two options to participate in the Contest's prize drawing:

1. No purchase or credit union transaction necessary to enter. To enter the Contest without a purchase or credit union transaction, UHFCU members may enter by writing their full name, address, date of birth, daytime phone number, e-mail address, and writing "Credit Card Holiday Shopping Sweepstakes" on a 3x5 postcard and hand-delivering to a UHFCU branch office or mailing to UHFCU, Attention: Marketing – Credit Card Holiday Shopping Sweepstakes, P.O. Box 22070, Honolulu, HI 96823. Limit one entry per member. Multiple entries by any one person, incomplete, or illegible entries will result in disqualification. Must be postmarked or hand-delivered by 6:00 p.m. (HST) on December 31, 2024.

2. Beginning November 1, 2024 – December 31, 2024, Platinum Plus or Cash Wave cardholders must do the following:

- 1) Receive one (1) entry when you spend at least \$1,000 on your card between November 1 - 30, 2024.
- 2) Receive one (1) entry when you spend at least \$1,000 on your card between December 1 - 31, 2024.

Up to (2) entries per member. Balance transfer funds, cash advances, and returns do not qualify.

Qualifying members will be entered into the random drawing to win the prize described above when they spend \$1,000 in November and/or December between November 1, 2024, through December 31, 2024. Members who successfully fulfill the spending requirements per month will earn one entry – up to a maximum of 2 entries per member (i.e. (1) November and (1) December).
